

*Diary of a Wimpy Kid: Double Down* New York Prize draw Terms and Conditions:

1. The purchase of at least one hardback edition copy of “Diary of a Wimpy Kid: Double Down” from any UK/EIRE store is necessary to enter the prize draw.

The Promoter accepts no responsibility for any entries that are incomplete, illegible, corrupted or fail to reach the Promoter by the relevant closing date for any reason. Entries become the property of the Promoter and are not returned.
